This is a publication put together by the Network on Police Reform in Nigeria [NOPRIN] and Connected Development [CODE] with support from Stanford University Center on Democracy Development and Rule of Law [CDDRL]

NOPRIN and CODE with support from CDDRL, Stanford University have created this Real-Time (Web-Based Map) Situation Awareness Platform (*PoliceMonitor.ng*) to enable the general public report police human rights abuses in their environment through various social media platforms. Police abuses include arbitrary arrests, unlawful detention, extortion, police brutality, torture, extrajudicial killings, rape and sexual misconduct, and other acts of police abuse and misconduct. We also mean to use this platform to connect our works with the Nigeria Police and organizations working around human rights issues in Nigeria.


PoliceMonitor will be civil society driven and compliment the NPF's Complaints Response Unit (CRU). The CRU, according to the NPF, is 'a multi-platform community-based complaint reporting mechanism' established by former Inspector General of Police, Solomon Arase 'to bridge the gap between the police and the citizens'. On the CRU's Whatsapp Status is written: 'we are here to address in real time all complaints, concern and queries regarding activities of officers and men of the NPF'.

The establishment of the CRU by former IGP was welcome and it was hoped that the platform would indeed; enable citizens to report in real time, their experiences with the police, and enable the police promptly respond to and resolve public complaints and distress calls- with the view of restoring public confidence in the police.

Relative to previous complaints mechanisms, the NPF-CRU represents a step forward in police complaints and discipline management and accountability. However, the saying that the police cannot effectively police itself remains a self-evident truth. Like all police internal control systems, the CRU has not been as efficient in operations and satisfactory in results as was hoped. There is, therefore, the need for an independent, external, citizen-driven complaints mechanism. It is hoped that the PoliceMonitorNG will compliment the NPF-CRU and other police internal control mechanisms and play the role of an alternative, external and independent citizens' platform to monitor and report police abuses in Nigeria and to take timely action to ensure justice for victims and accountability by perpetrators.

In the first two months of the launch of this platform, July and August a total of 34 complaints/reports were received. From the analysis, complaints of demand for a bribe for bail, the involvement of police officers in armed robbery, the involvement of police officers in illegal/ forced evictions of tenants, illegal raids for a bribe, and police officers stealing from persons in police custody were some of the most reported cases. Extrajudicial killings, torture, forced evictions; rape and sexual misconduct were the less reported cases during the same period.

It is hoped that police authorities and oversights agencies will look into the complaints documented in this and subsequent report with a view to ensuring redress and accountability, while also using this report generally as a guide to policing planning, response and policy direction.



Harassment of citizens by the Nigeria Police remains the most reported of the 107 cases in July 2016 and August 2016.

Demand for money for bail, vandalization of citizens property, forced eviction, illegal raids, stealing in custody were the next most reported in July and August 2016.

Extra-judicial killing, cover up, rape and sexual Misconduct, and Police involvement in armed robbery were the least reported cases in July and August 2016.
